- ✓ Public playgrounds must comply with all playground related specifications of ASTM and CPSC, the two standards required by the state of California.
- ✓ Before a playground is open to the public, it must be inspected and approved by a NPSI Certified Playground Safety Inspector. Installation by a Manufacturer authorized installer is not sufficient.
